This admission process for only students of GLC, outsider students are not allowed.

In-house online admissions of Second & Third Year of Three Year & Second, Third, Fourth & Fifth Year of Five Year Law Course 2025-26 admission date will be Extended. Students will have to click the link which is provided by the College.

Students should pay only by scanning QR Code or Bank Details given in the admission form. The students will have to upload screenshot of admission payment receipt.

If the College Administrative is satisfied with the information given in the form and documents uploaded, college will publish Provisional roll number wise list on the website/Email. **All admissions are subject to confirmation of college.**

Ex-students must report to college for admission on or before 31thJuly, 2025. The students are informed to pay the requisite fees & confirm their admission on or before 31th of July, 2025 upto 11.00 p.m. Thereafter no admission will be given.

The students will be required to **fill true and correct information**. Please note that the last date of admission is 31th July 2025, up to 11:00 p.m. **The deadline will not be extended under any circumstances.**

In case of any doubts or issues related to documents, students are strictly advised to visit the college in person. Do not contact via WhatsApp or phone for such queries.

ELIGIBILITY FOR IN-HOUSE ADMISSION

Students are advised to carefully read the eligibility criteria mentioned on the website before proceeding with admission.

Students who have failed in more than three subjects will not be eligible for admission for Second & Third Year of Five Year Law Course

Students who have failed in more than three subjects will not be eligible for admission for Fourth & Five Year of Five Year Law Course & Second & Third Year of Three Year Law Course

For the Five-Year Law Course:

- Students seeking admission to the Third Year must have passed all subjects of the First Year.
- Students seeking admission to the Fourth Year must have passed all subjects of the First and Second Year.
- Students seeking admission to the Final Year (Fifth Year) must have passed all subjects of the First, Second, and Third Year.

For the Three-Year Law Course:

• Students seeking admission to the Third Year must have passed all subjects of the First Year. Otherwise, they will not be eligible for the admission process.

Further, if a student has failed or remained absent in internal subjects, such subjects will be treated as KT/FAIL.
